INTRODUCTION

The International Registry of Mobile Assets ("the Registry") was established pursuant to the provisions of the Cape Town Convention and Protocol.¹

The International Civil Aviation Organisation ("ICAO") is the Supervisory Authority of the Registry² and Aviareto Limited is the Registrar of the Registry³.

Section 10.1 of the Regulations for the Registry ("the Regulations")⁴ requires that

"the Registrar shall maintain updated registration statistics and shall publish them in an annual report. This report shall be electronically accessible to any person".

Section 10.2 of the Regulations states that "registration statistics" shall consist of:

"(a) transactional volumes and revenues subdivided in each case by registration type and geographic distribution; and (b) other compilations of non-confidential information requested by the Supervisory Authority".

This third annual statistical report is being posted on the Registry website in fulfilment of the requirements of Section 10 of the Regulations.

- 3. The **revenues** set out in this Report (other than in the statutory accounts) are based on the payment received at the time of each transaction. In the statutory accounts revenues received in respect of user set-up and renewal fees (1 year or 5 year) are recognized in equal monthly amounts over the life of the licence purchased (that is, over 12 or 60 months respectively).

REVIEW OF THE REGISTRY IN 2008

Bangladesh acceded to the Convention and Protocol and deposited its instruments of accession on 15 December 2008. The Convention and Protocol came into force for Bangladesh on 1 April 2009.

The Contracting States at the end of 2008 accounted for some 41% of all of the world's aircraft objects that potentially qualify for registration on the Registry. The United States of America, based on revenue, was the origin of 91% of all activity on the Registry. The remaining registry user activity and revenue originated from Ireland (2.6%) and the United Kingdom (1.2%), and seventy-one other countries.

Activity levels

Levels of activity in 2008 were lower than the previous year with the impact of the international recession and financial crisis becoming first noticeable in quarter two and deepening thereafter. The population of Cape Town qualifying aircraft objects was broadly the same as in the prior year. There was a fall in registrations against airframes and associated engines of 9% (one registration session and typically three individual registrations) and a rise in registrations against spare engines (one registration and one registration session) of 50% which explains the increase in registration sessions and simultaneous decrease in the number of individual registrations noted below. The following were the main changes:

Number of objects against which interests were registered: -3.5%
Number of individual registrations made: -5.2%
Number of registration sessions: +5.3%
Number of priority search sessions: -6.8%

Administrators and users

The number of new administrators and users approved to work on the Registry declined from 6,822 in 2007 to 5,402 in 2008, a drop of 20.8%. This decline was expected as the balance shifted between newly approved administrators and users to those with existing accounts who renew.

Of the 4,321 administrators and users who purchased one year licences in 2007, 1,441 (33.3%) renewed in 2008. This is up from a figure of 22.8% the previous year. One year licences were bought by 1,034 (71.7%) of those renewing and the balance were five year licences⁷. This was up from a figure of 68.8% in 2007.

Manufacturers Serial Numbers

By the end of 2008, 41 manufacturers were regularly supplying the Registry with updates of the manufacturer serial numbers (MSNs) of airframes, helicopters and engines. As a result, some 273,000 MSNs are stored on the Registry system. This information is electronically supplied to users making registrations. The use of such information, where supplied, is mandatory under Section 5.1 of the Regulations.

The cooperation of manufacturers in supplying this data to the Registry was arranged through the Aviation Working Group. Efforts are continuing to encourage additional manufacturers' participation in the scheme and thereby

reduce further the need for the "free texting" of object identification data although no new manufacturers joined during 2008.

Registry availability

Article 12.1.4 of the Contract requires the Registrar to maintain a system availability of 99.6% (including down time for regular maintenance). The availability achieved in 2008 was 97.67% compared to 99.35% in 2007 and 97.55% in 2006.

The Contract target of 99.6% was achieved or exceeded in seven of the months including five months with 100% availability. However, of the remaining five months, the most significant downtime was experienced during January, June and August.

During January an attempted software upgrade was abandoned following difficulties with the replication of data between the two sites which host the International Registry system. A period of review followed where additional database expertise was deployed to assist with the software upgrade which was then successfully achieved in May. During June, an error was reported by a user whereby a registration appeared in the Registry not as the user had entered it. A second case was then reported. The Registrar took the decision to bring the Registry system off-line until the issue could be resolved. Most of the down time occurred over the weekend of 14 and 15 June. The fault was rectified and the system restored on Tuesday the 17th. The individual registrations in question were capable of being corrected by the user through the normal functions of the Registry and the users in question were happy to proceed on that basis. The Supervisory Authority was informed of the issue. During August an Internet Service Provider DNS service operated by an external organisation became unavailable for 16.5 hours blocking access for some users. This supplier has been replaced.

Improvements to the Registry system

The Batch 3 software, released in May, was the most significant improvement to the Registry system during 2008. It included an enhanced informational search facility (SearchPath) and a strengthened data input validation checking system. The SearchPath function forces users to do an informational search prior to a Priority Search so that they are aware of any similar registrations or objects on the system. Informational searches became free from the date of the release. The data validation enhancement was a security measure to ensure that users could not enter commands into data fields.

A review of several database queries allowed an improvement in system speed.

Registry system security

No security review was carried out during 2008 although a report was received based upon a review carried out in late 2007. The report received in 2008 was satisfactory and no issues of concern were raised. The supplier of security services underwent organisational changes and, during 2008, became less focused on this line of business. This led to them becoming unresponsive to the Registrar's needs and a new security firm (PWC) was retained following a tendering process. PWC is considered to be one of the leading firms in this field operating today⁹ and will be carrying out security reviews in 2009.

Liability insurance

Errors and omissions insurance cover was increased to \$40 million (from \$35 million in 2007) in respect of risks contemplated by Article 28 of the Convention.

Complaints

Section 8 of the Regulations and Section 14 of the Procedures make provision for operational complaints about the procedures and policies of the Registry. There is also provision for dissatisfied complainants to have recourse to the Supervisory Authority.

Of the seven operational complaints received by the Registrar during 2008, six were deemed to be proper and none resulted in a submission to the Supervisory Authority. Details of these complaints are provided in Table 10.

Liaison with the user community

The Registrar continued to maintain close contact with the user community during the year and conducted a formal survey of customer opinion during the second half of the year. The outcomes of the survey were important in the shaping of the programme for the Registry's future development. The Registrar took part in a participatory seminar at Fordham University, New York, USA, an aircraft registry conference in Fort Lauderdale, Florida, USA, and conferences in Geneva and Dublin focusing more generally on Cape Town.

The International Registry Advisory Board continued to provide advice and guidance to the Registrar and to contribute substantially to the development of policy and practice. It also acts as a valuable channel for user feedback.

Commercial Court of the Irish High Court

With effect from 12 March 2008, the Rules of the Superior Courts in Ireland have been amended to permit any proceedings by or against the Registrar in

connection with any function exercised or exercisable by the Registrar under the Cape Town Convention or the Aircraft Protocol or any regulations or procedures made thereunder to be brought as commercial proceedings in the Commercial Court, which is a division of the Irish High Court. Any party taking such proceedings has the option of bringing such proceedings in the Commercial Court but is not obliged to do so. This means that any party (including the Registrar) wishing to institute proceedings has a specific right to have such proceedings heard in the Commercial Court, which is located in Dublin. procedural rules relating to proceedings bought in the Commercial Court mean that the proceedings will be processed expeditiously. However, proceedings in which only damages are claimed cannot be brought in the Commercial Court, but where other reliefs and remedies are sought, damages can also be claimed. Where any relief is sought in such proceedings before the Commercial Court affecting any entry or registration in the International Registry, the Registrar shall (if not the applicant) be a respondent to such proceedings. The proceedings are commenced by notice of motion and must contain a special endorsement of claim which must state specifically and with all necessary particulars the relief (other than damages) sought against each respondent and the grounds for same. The overall effect of these changes will be to permit proceedings by or against the Registrar to be dealt with in a faster and more efficient manner.

Tax free status

As a result of an application by the Registrar, the Irish Revenue Commissioners agreed that the Registrar should not be subject to corporation tax in respect of its main operation, in the light of the role of the Registry and its cost recovery and non-profit-distributing characteristics. The concession will be reviewed periodically and does not extend to earnings from the Registrar's cash flow. This concession was renewed for 2008.

ISO 9001: 2008 Quality Management Framework

In December 2008 the Registrar achieved the ISO9001 quality accreditation for the operation and development of the International Registry. The accreditation was certified by the National Standards Authority of Ireland.

Financial performance of the Registrar


The statutory accounts of the Registrar for 2008 as filed with the Irish Companies Registration Office are included in this report.

The Registry had a surplus of \$516,199 of income over expenditure in 2008 (\$970,213: 2007) enabling it to reduce its accumulated deficit to \$31,978 (\$548,177: 2007) comprised of -\$272,013 of retained earnings and \$240,035 of called-up share capital. In the course of the year, capital expenditure on the system of \$317,389 was incurred and the Registrar's working capital debt to SITA and its affiliates was reduced from \$513,055 to nil. At year end the Registry had deferred revenue obligations to its users of \$2,873,644 (\$2,413,950 in 2007).

Table 10 – Operational complaints made to the Registrar (2008)

Section 8 of the Regulations, read with Section 14 of the Procedures¹², provides that any person can make a complaint to the Registrar "concerning the operation of the International Registry" where "the matter relates to the general procedures and policies of the International Registry and does not involve specific adjudication by the Registrar or the Supervisory Authority". If the complaint is not satisfactorily addressed by the Registrar within 30 calendar days of making the complaint the complainant may appeal to the Supervisory Authority.

During 2008, there were seven operational complaints made to the Registrar. None of these gave rise to a complaint to the Supervisory Authority.

Table 11 outlines the availability actually achieved based on the standard that if any function of the Registry is unavailable to users then the system as a whole is treated as being unavailable. The average availability for 2008 was 97.67% compared to a figure of 99.35% for 2007.
