INTRODUCTION

The International Registry of Mobile Assets ("the Registry") was established pursuant to the provisions of the Cape Town Convention and Protocol.¹

The International Civil Aviation Organization ("ICAO") is the Supervisory Authority of the Registry² and Aviareto Limited is the Registrar of the Registry³.

Sections 10.1 of the Regulations for the registry ("the Regulations")⁴ requires that

"the Registrar shall maintain updated registration statistics and shall publish them in an annual report. This report shall be electronically accessible to any person".

Section 10.2 of the Regulations states that "registration statistics" shall consist of:

"(a) transactional volumes and revenues subdivided in each case by registration type and geographic distribution; and (b) other compilations of non-confidential information requested by the Supervisory Authority".

This fourth annual statistical report is being posted on the Registry website in fulfilment of the requirements of Section 10 of the Regulations.

In the statutory accounts revenues received in respect of user set-up and renewal fees (1 year or 5 year) are recognized in equal monthly amounts over the life of the licence purchased (that is, over 12 or 60 months respectively).
- 4. The data in the Report have been extracted from the logs of the Registry and the Registry database.

The United States of America, based on revenue, was the origin of 86% of all activity on the Registry, down from 91% in 2008. The remaining revenue originated in Ireland (3.3%), the United Kingdom (2%) and seventy-two other countries.

Activity levels

Levels of activity were lower than the previous year with the impact of the international recession and financial crisis continuing. Whilst there was a slight drop of 2.31% in the total number of registrations made in 2009 compared with 2008, the number of registration sessions decreased by 24%. This would indicate greater cost efficiency for users with the average number of registrations per session increasing from 3 to 4. Interestingly, the number of spare engine sessions fell from 5,341 in 2008 to 3,258 in 2009, a drop of 39%. The number of priority search sessions fell by 27%. This may have been as a result of the search session time limit being extended from 30 to 60 minutes, therefore facilitating more searches per session. The following were the main changes:

Administrators and users

The number of new administrators and users approved to work on the Registry declined from 5,402 in 2008 to 4,073 in 2009, a drop of 25%. This decline was expected as the balance shifted between newly approved administrators and users renewing existing accounts.

Overall, the total number of renewals in 2009 was 1,204, down 16% from 2008. One year licences were purchased by 973 (80%) of those renewing and the remainder were five year licences⁶. Of the 3,331 administrators and users who purchased one year user licences in 2008, 973 (29%) renewed in 2009. This figure was down 3% on the one year renewal figures for 2008.

Manufacturers Serial Numbers

By the end of the year, 41 manufacturers were regularly supplying the Registry with updates of the manufacturer serial numbers (MSNs) of airframes, helicopters and engines. As a result, some 280,811 MSNs are stored on the Registry system. This information is electronically supplied to users making registrations. The use of such information, where supplied, is mandatory under Section 5.1 of the Regulations.

The cooperation of manufacturers in supplying this data to the Registry was arranged through the Aviation Working Group.

Registry availability

Article 12.1.4 of the Contract requires the Registrar to maintain a system availability of 99.6% (including down time for regular maintenance). The availability achieved in 2009 was 99.32% compared to 97.67% in 2008, 99.35% in 2007 and 97.55% in 2006.

The Contract target of 99.6% was achieved or exceeded in six months of the year. However, of the remaining six months, the most significant downtime was experienced during the period September to December. This was largely due to planned maintenance required to complete an infrastructure upgrade project⁷ and technical difficulties experienced during that project.

Improvements to the Registry system

The Batch 4 software, released in March, included several significant improvements to the Registry system. Registration of amendments was enhanced to allow all registration data to be amended and, where applicable, to process an automatic discharge of the underlying registration. Special purpose entities were replaced by controlled entities and a controlled entity set-up fee was introduced. New functionality was introduced to allow administrators to submit a request to change their entity name for approval by the Registrar. The entity search functionality was also improved and a search box is now provided wherever a user must select an entity, replacing the previous drop-down menu. The entity search returns additional contact details on the entity and its administrator. For registrations of assignments and subordinations, a cross check has been included to confirm the assignor or holder of the subordinated right is one of the named parties to the underlying registered interest. Users registering interests or requesting authorization using free text are now provided with an additional warning and referred to the Regulations. Approved users may now opt in or out of email notifications. The time limit of search sessions has been increased to 60 minutes. The fields "Aircraft Nationality" and "Registration Marks" were replaced by one field, "Nationality and Registration Marks". Selection of the State of Registry now allows a user to select the State from a drop down list or indicate 'Not Known'. Changes were also made to the layout of the Contracting State search certificate.

Registry system security

The most significant security improvement was the completion of an infrastructure upgrade. The upgrade introduced layered firewalls separating the web, application and database servers. The SMTP⁸ functionality was separated from the other database servers to its own server to further increase security and flexibility.

As part of the risk mitigation efforts of the company, Aviareto has initiated a series of annual reviews by external consultants related to the operation of the International Registry system, including security and technical audits, and a review of "best practices". Accordingly, PricewaterhouseCoopers conducted an annual security review of the system. The scope of the review included operational and technical security controls, the Application⁹ and the Registry infrastructure. Several recommendations were made and, following discussions with the subcontractor SITA, these are being or have been addressed. PricewaterhouseCoopers is contracted to do a midterm review during 2010 to assess the status of these recommendations which will be followed by another full security review later in 2010. Management is satisfied that the issues found cause no significant risk to the International Registry.

Liability insurance

Errors and omissions insurance cover was increased to \$50 million (from \$40 million in 2008) in respect of risks contemplated by Article 28 of the Convention.

Complaints

Section 8 of the Regulations and Section 14 of the Procedures make provision for operational complaints about the procedures and policies of the Registry. There is also provision for dissatisfied complainants to have recourse to the Supervisory Authority.

There were no complaints made in 2009.

Liaison with the user community

The Registrar continued to maintain close contact with the user community and conducted its customary annual survey of customer opinion during the second half of the year. The outcome of the survey was important in the shaping of the programme for the Registry's future development. The Registrar took part in two Cape Town participatory seminars, the first in London (March) and the second in Singapore (November), as well as an Aircraft Registry Forum in Naples, Florida (February).

The International Registry Advisory Board continued to provide advice to the Registrar and to contribute substantially to the development of policy and practice. It also acted as a valuable channel for user and industry feedback.

Tax free status

The concession granted by the Irish Revenue Commissioners to the Registrar exempting corporation tax in respect of its operation of the International Registry was renewed for 2009.

ISO 27001: 2005 Information Security Management System

In November the Registrar achieved the ISO27001 accreditation for the information security procedures and operational practices of the International Registry. The accreditation was certified by the British Standards Institute.


Financial performance of the Registrar

The Balance Sheet of the Registrar for 2009 as filed with the Irish Companies Registration Office is included in this report.

The Registrar had a surplus of \$238,769 of income over expenditure in 2009 (\$516,199: 2008) enabling it to achieve an accumulated shareholders' fund of \$206,791 (-\$31,978: 2008) comprised of -\$33,244 of retained earnings and \$240,035 of called-up share capital. In the course of the year, capital expenditure on the system of \$595,076 was incurred. At year end the Registrar had deferred revenue obligations to its users of \$2,884,458 (\$2,873,644 in 2008).
