#### INTRODUCTION

The International Registry of Mobile Assets ("the Registry") was established pursuant to the provisions of the Cape Town Convention and Aircraft Protocol.<sup>1</sup>

The International Civil Aviation Organization ("ICAO") is the Supervisory Authority of the Registry<sup>2</sup> and Aviareto Limited is the Registrar of the Registry<sup>3</sup>.

Sections 10.1 of the Regulations for the International Registry<sup>4</sup> ("the Regulations") requires that

"The Registry shall maintain updated registration statistics and shall publish them in an annual report. This report shall be electronically accessible to any person".

Section 10.2 of the Regulations states the "registration statistics" shall consist of:

"(a) transactional volumes and revenues subdivided in each case by registration type and geographic distribution; and (b) other compilations of non-confidential information requested by the Supervisory Authority".

This seventh annual statistical report is being posted on the Registry website in fulfilment of the requirements of Section 10 of the Regulations.

- 3. The **revenues** set out in this report (other than in the statutory accounts) are based on the payment received at the time of each transaction. In the statutory accounts revenues received in respect of user set-up and renewal fees (1 year or 5 year) are recognized in equal monthly amounts over the life of the licence purchased (that is, over 12 or 60 months respectively)<sup>6</sup>.
- 4. The data in this report have been extracted from the logs of the Registry and the Registry database and all monetary amounts are in US\$.

Bahrain and Myanmar deposited their instruments of accession to the Convention and Protocol on 27 November 2012 and 3 December 2012 respectively, and Canada deposited its instrument of ratification to the Convention and Protocol on 21 December 2012. The Convention and Protocol came into force on 1 March 2013 for Bahrain and on 1 April 2013 for both Canada and Myanmar.

The United States, based on revenue, was the origin of 79% of all activity on the Registry, down from 82% in 2011. The remaining revenue originated in Ireland (5.5%), the United Kingdom (2.2%) and one hundred and four other States and territories.

# **Activity levels**

All categories of activity continued to grow with the exception of priority search sessions. The number of priority search sessions was marginally down from 45,846 in 2011 to 45,166 in 2012, representing a decrease of 1.48%, due to reduced demand or increased efficiency on behalf of registry users or both. The Registrar issued 73,406 priority search certificates in 2012, an increase on the previous year, indicating that registry users have become more efficient by increasing the number of search certificates per search session. It was a record year for registrations with the number of registration sessions increasing 2.45% to 17,214 and the number of registrations increasing by 14.23% to 72,034<sup>10</sup>, again indicating increased efficiency on behalf of registry users. Spare engine registration sessions also increased by 1.7% to 5,256. These registration figures are the highest numbers recorded since the system went live in 2006. Registrations were made against 24,948 objects, a marginal increase from 24,862 in 2011.

#### Administrators and users

The total number of administrators and users approved grew by 4.11% to 5,310 from 5,100 in 2011. Licence renewals saw a significant increase of 39% to 3,505. This was the second consecutive year of growth for renewals which may be accounted for by the expiry of many 5 year licences issued in 2007, the removal of the five year option requiring more frequent renewals or just economic growth and new ratifications. Looking at the newly approved licences plus renewed licences, the figure for 2012 of 9,198 is the highest figure since operations began, the previous highest being 8,043 in 2007.

#### **Manufacturers Serial Numbers**

By the end of the year, 42 manufacturers were regularly supplying the Registry with updates of the manufacturer serial numbers (MSNs) of airframes, helicopters and engines. As a result, approximately 315,000 MSNs are stored on the Registry system. This information is electronically supplied to users making registrations. The use of such information, where supplied, is mandatory under Section 5.1 of the Regulations.

The cooperation of manufacturers in supplying this data to the Registry was arranged through the Aviation Working Group.

# Registry availability<sup>11</sup>

The availability achieved in 2012 was 98.82% compared to 99.73% in 2011. This was mainly due to a series of database upgrades that were required in preparation for Generation II of the International Registry website.

### Improvements to the Registry system

There were no significant infrastructure upgrades in 2012 apart from software upgrades to infrastructure components to maintain and enhance security. The development of Generation II of the International Registry software continued throughout 2012 with go-live for Phase 1 anticipated for summer 2013.

There were two International Registry software releases in 2012 which included bug fixes and enhancements. In January 2012 version 1.8.6 of the International Registry system was released which fixed, *inter alia*, a bug that was preventing users from performing certain discharges. Version 1.8.7 was released in June 2012. Details of both releases are outlined in Table 12 below.

## Registry system security

The practice adopted by the Registrar for Registry system security is to conduct a full security audit (the Audit) each year and to follow that up, roughly six months later, with a review of progress on the issues raised in the Audit (the Review). PwC is the current security contractor. PwC carried out its first Audit in 2009.

A new International Registry infrastructure was implemented in November 2011. PwC conducted an audit in January 2012 considering issues that were raised in previous audits and sought to identify any new issues which may have arisen as a result of the new infrastructure. A further audit was performed in November 2012 which re-assessed issues raised in the earlier 2012 audit. The majority of issues raised in both 2012 audits have been addressed by the Registrar. As a result of the Generation II software development project, PwC and Deloitte will be conducting a number of security audits prior to go live in 2013. Having external experts regularly review the security of the International Registry system is a key control in the area of cyber-security.

#### Liability insurance

Errors and Omissions insurance cover was increased to \$120 million (from \$100 million in 2011).

#### **Complaints**

Section 8 of the Regulations and Section 14 of the Procedures make provision for operational complaints about the procedures and policies of the Registry. There is also provision for dissatisfied complainants to have recourse to the Supervisory Authority.

One complaint was received by the Registrar during 2012 and it did not result in a submission to the Supervisory Authority. Details of this complaint are provided in Table 11.

#### Liaison with the user community

The Registrar continued to maintain close contact with the user community and conducted its customary annual survey of customer opinion during the second half of the year. Feedback from the user community and the outcome of the survey were important in the shaping of the programme for the Registry's future development. The overall weighted Registry user experience achieved a composite score of 7.87 (out of 10) in 2012 up from 7.78 in 2011. There has been continuous improvement in this figure since the survey commenced in 2007. The Registrar took part in several Cape Town and related seminars, including in Phoenix (February), Berlin (February), Las Vegas (March), Sao Paulo (April), Bangkok (April), Oxford (September), Ankara (October) and Oklahoma City (October).

The International Registry Advisory Board (IRAB) continued to provide advice to the Registrar and to contribute substantially to the development of policy and practice. It also acted as a valuable channel for user and industry feedback.

#### Tax free status

The concession granted by the Irish Revenue Commissioners to the Registrar exempting corporation tax in respect of its operation of the International Registry was renewed for 2012.

# International Standards Organisation (ISO) 27001:2005 Information Security Management System and 9001: 2008 Quality Management Standards

Following external audits conducted by the National Standards Authority of Ireland and the British Standards Institute, Standard ISO 9001:2008 was successfully renewed until November 2014 and ISO 27001:2005 remains valid until October 2015. In November 2012, the Registrar commenced preparations to attain a new standard, ISO22301:2012 Business Continuity Management Systems.

# Financial performance of the Registrar

The Balance Sheet of the Registrar for 2012 as filed with the Irish Companies Registration Office is included in this report.

The Registrar had a surplus of \$1,049,964 of income over expenditure in 2012 (\$1,158,823: 2011) enabling it to achieve an accumulated shareholders' fund of \$2,997,969 (\$1,948,005: 2011) comprised of \$2,757,934 of retained earnings and \$240,035 of called-up share capital. In the course of the year, capital expenditure on the system of \$1,886,491 was incurred. At year end the Registrar had deferred revenue obligations to its users of \$1,416,222 (\$1,945,101 in 2011).

#### Case brought under Article 44 of the Convention

Under Article 44 of the Cape Town Convention, "the courts of the place in which the Registrar has its centre of administration shall have exclusive jurisdiction to award damages or make orders against the Registrar".


As the Registrar is located in Ireland, the Irish High court has exclusive jurisdiction to award damages and make orders against the Registrar. The relevant Irish legislation is the International Interests in Mobile Equipment (Cape Town Convention) Act 2005 with procedural matters set out in Order 81A of the Rules of the Superior Courts, S.I. No. 31 of 2008.

In December 2012 the first case taken under Article 44 of the Convention came before the President of the Irish High Court, Mr. Justice Nicholas Kearns. The case centred around Registerable Non-Consensual Interests registered on the International Registry against an airframe and three engines. The applicant brought proceedings seeking to have the registrations discharged after a Minnesota Court Order directing their discharge had not been complied with. The Registrar was a named Respondent in these proceedings as prescribed by the Rules of the Superior Courts. The Court made an Order in favour of the applicant on 19 December 2012 under case reference 2012 397 MCA.

Section 8 of the Regulations, read with Section 14 of the Procedures<sup>21</sup>, provides that any person can make a complaint to the Registrar "concerning the operation of the International Registry" where "the matter relates to the general procedures and policies of the International Registry and does not involve specific adjudication by the Registrar or the Supervisory Authority". If, within 30 calendar days of making the complaint, the person does not consider that the matter has been or is being satisfactorily addressed by the Registrar, that person may submit the complaint to the Supervisory Authority.

During 2012, there was one operational complaint made to the Registrar. It did not give rise to a complaint to the Supervisory Authority.
