INTRODUCTION

The International Registry of Interests in Aircraft Equipment ("the Registry") was established pursuant to the provisions of the Cape Town Convention and Aircraft Protocol.¹

The International Civil Aviation Organization ("ICAO") is the Supervisory Authority of the Registry² and Aviareto Limited is the Registrar of the Registry³.

Section 10.1 of the Regulations for the International Registry⁴ ("the Regulations") requires that

"The Registry shall maintain updated registration statistics and shall publish them in an annual report. This report shall be electronically accessible to any person".

Section 10.2 of the Regulations states "the registration statistics" shall consist of:

"(a) transactional volumes and revenues subdivided in each case by registration type and geographic distribution; and (b) other compilations of non-confidential information requested by the Supervisory Authority".

This twelfth annual statistical report is being posted on the Registry website in fulfilment of the requirements of Section 10 of the Regulations.

Activity levels

All categories of activity grew in 2017. Registrations increased by 10.9% to 131,562 from 118,940 the previous year. This was the highest number of registrations recorded since go-live in 2006. Registrations were effected against 36,129 unique objects. Registration revenue increased by 12% to \$2,183,300.

The number of priority search certificates issued, increased by 3.2% from 109,730 in 2016 to 113,276 in 2017. The revenue generated by searches was \$2,492,072.

There were notable variations in the number of certain registration types effected in 2017. The number of registrable non-consensual rights or interests (RNCRIs) effected fell from 145 in 2016 to 45 in 2017, a decrease of 69%. This may be attributable to the Seventh Edition of the *Regulations and Procedures for the International Registry* which was published in November 2016. This Edition introduced additional requirements for users when effecting registrable non-consensual rights or interests. Indeed in both 2016 and 2017, the number of RNCRI discharges exceeded the number of RNCRIs effected. The registration of subordinations grew by 153% from 1,385 in 2016 to 3,507 in 2017.

Of the 131,562 registrations in 2017, 49.9% of these were effected in a Closing RoomTM. In 2016 just 36% of all registrations were effected in a Closing RoomTM.

The changes in activity levels against the previous year are noted in the table below.

Administrators and users

The number of new administrators and users grew in 2017, as did licence renewals. New administrators and users grew by 2.5% to 7,166 compared with 6,993 in 2016. Licence renewals also grew by 10.7% to 6,214 in 2017 from 5,615 in 2016. The number of controlled entities created fell by 21% from 378 in 2016 to 300 in 2017. The number of controlled entity renewals fell by 7.6% from 895 in 2016 to 827 in 2017.

Manufacturer Serial Numbers

By the end of the year, 54 manufacturers were regularly supplying the Registry with updates of the manufacturer serial numbers (MSNs) of airframes, helicopters and engines. As a result, approximately 363,000 MSNs are now stored on the Registry system. This information is electronically supplied to registering users. The use of such information, where supplied, is mandatory under Section 5.1 of the Regulations.

The cooperation of manufacturers in supplying this information to the Registry was arranged through the Aviation Working Group.

Registry availability⁸

The availability achieved in 2017 was 98.91% compared to 99.61% in 2016. Planned outages, described below, to implement new infrastructure accounted for the decrease in availability in 2017.

Improvements to the Registry system

In August 2017, the Registrar implemented its largest infrastructure project since it went live in 2006. This project took over two years to complete from design stage to go-live. The International Registry infrastructure was designed with increased resilience, redundancy and security in mind. There are now three data centres in operation with real time data replication. The International Registry software was further developed to facilitate the additional redundancy of the new infrastructure.

A significant piece of developed software was released to users in October 2017. The Registrar designed an in-house solution, SecureSignIR, to facilitate user authentication and digital signing using existing PKI⁹ infrastructure. SecureSignIR was designed to address imminent changes in

browser technology that would have caused users issues when logging on and digitally signing their transactions. SecureSignIR also improves the certificate renewal process, an issue which gave rise to an official complaint by a user in October 2017. Other application improvements included the provision of the "Official Commentary to the *Convention on International Interests in Mobile Equipment and Protocol thereto on matters specific to Aircraft Equipment"*, ¹⁰ to registered users in electronic format, free of charge.

In addition to the testing performed by the development team and the Registrar, all new software was tested by an external consultant, PricewaterhouseCoopers (PwC), on the production environment with the goal of identifying security vulnerabilities and resolving them prior to release.

Registry system security

The practice adopted by the Registrar for Registry system security is to conduct a full security audit (the Audit) each year and to follow that up throughout the year, reviewing progress on the issues raised in the Audit. PwC carried out its first Audit in 2009. Prior to deployment of the new infrastructure in August 2017, a comprehensive security audit was performed by PwC. Any significant issues identified were resolved prior to go-live and those remaining were addressed taking a risk based approach.

Liability insurance

Errors and omissions insurance cover remains at \$200 million.

Complaints

Section 8 of the Regulations and Section 14 of the Procedures make provision for operational complaints about the procedures and policies of the Registry. There is also provision for dissatisfied complainants to have recourse to the Supervisory Authority.

There were two official complaints received by the Registrar in 2017. Details of both complaints can be found at Table 9 below.

Liaison with the user community

The Registrar continued to maintain close contact with the user community and conducted its customary annual survey of customer opinion during the second half of the year. Feedback from the user community and the outcome of the survey are important in the shaping of the programme for the Registry's future development. The overall weighted Registry user experience achieved a composite score of 8.48 (out of 10) in 2017 representing a marginal decrease from 8.53 in 2016.

The Registrar took part in several Cape Town Convention and related seminars, including in Fort Myers (March), Dubai (May), London (May), Toronto (June), Seattle (August), Oxford (September) and Singapore (November).

Registry Officials also provided face to face training seminars to users which took place in Dublin in April, June and November.

The International Registry Advisory Board continued to provide advice to the Registrar and to contribute substantially to the development of policy and practice. It also acted as a valuable channel for user and industry feedback.

Tax free status

The concession granted by the Irish Revenue Commissioners to the Registrar exempting corporation tax in respect of its operation of the Registry was renewed for 2017.

International Standards Organisation (ISO)

The Registrar achieved a successful re-certification audit to Standard ISO 9001:2015¹¹ with the National Standards Authority of Ireland. Successful surveillance audits were also carried out by the British Standards Institute on Standards ISO 27001:2013¹² and ISO 22301:2012¹³. Re-certification audits for both ISO 27001:2013 and ISO22301:2012 will take place in 2018.

Financial performance of the Registrar

The Balance Sheet of the Registrar for 2017 as filed with the Irish Companies Registration Office is included in this report.

The Registrar had a surplus of \$600,679 of income over expenditure in 2017 (\$1,098,348 in 2016) enabling it to achieve a shareholders' surplus of \$7,704,807 (\$7,103,828 in 2016) comprising \$7,464,772 of retained earnings and \$240,035 of called-up share capital. In the course of the year, capital expenditure on the system of \$3,263,967 was incurred. At year end the Registrar had deferred revenue obligations to its users of \$1,342,262 (\$1,271,717 in 2016).

Cases brought under Article 44 of the Cape Town Convention

Under Article 44 (1) of the Cape Town Convention, "[t]he courts of the place in which the Registrar has its centre of administration shall have exclusive jurisdiction to award damages or make orders against the Registrar".

As the Registrar is located in Ireland, the Irish High Court has exclusive jurisdiction to award damages and make orders against the Registrar. The relevant Irish legislation is the *International Interests in Mobile Equipment (Cape Town Convention) Act 2005* with procedural matters set out in Order 81A of the *Rules of the Superior Courts*, S.I. No. 31 of 2008.

In 2017 five cases were decided before the High Court in Ireland. The Registrar was a named Respondent in these proceedings as prescribed by the Rules of the Superior Courts.

The first case related to a dispute between registering parties concerning the existence of a registration on the International Registry following the termination of a lease. The applicant brought the case seeking to have the other named party discharge the registration in question. The Court ordered the named party in the registration to effect a discharge, failing which the Registrar was ordered to do so. The Order was not complied with by the named party and the Registrar duly effected the discharge of the registration.

The second and third cases related to registrations on a number of objects, where the holder of the right to discharge was dissolved. Each applicant brought a case seeking to have the Registrar effect the discharges. The Court made the order and the Registrar duly performed the discharges.


In addition to Article 44, the fourth case proceeded under Articles 20, 25 and 40 of the Cape Town Convention. This related to a registrable non-consensual right or interest registered on the International Registry. The applicants brought proceedings seeking to have the registration discharged by the registering party. Although the Court was satisfied to direct the registering party to effect the discharge, due to exceptional circumstances with regard to the timing of the discharge, the Court directed the Registrar (with the Registrar's consent) to do so directly.

In addition to Article 44, the fifth case proceeded under Articles 25 and 40 of the Convention. This case related to a registrable non-consensual right or interest registered on the International Registry. The applicants brought proceedings seeking to have the registration discharged by the registering party. The Court ordered the registering party to effect the discharge failing which the Registrar was to effect the discharge. The Order was not complied with by the registering party and the Registrar duly effected the discharge of the registration.

Sources of Revenue





There is a contractual target to maintain a system availability of 100%, subject to the provisions of the Service Level Agreement.¹⁷

Table 7 outlines the availability actually achieved based on the standard that if any function of the Registry is unavailable to users then the system as a whole is treated as being unavailable. The average availability for 2017 was 98.91% compared to 99.61% for 2016.

Section 8 of the Regulations, read with Section 14 of the Procedures²¹, provide that any person can submit a complaint to the Registrar "concerning the operation of the Registry" where "the matter relates to the general procedures and policies of the Registry and does not involve specific adjudication by the Registrar or Supervisory Authority". If, within 30 calendar days of making the complaint, the person does not consider that the matter has been or is being satisfactorily addressed by the Registrar, that person may submit the complaint to the Supervisory Authority.

During 2017, there were two operational complaints made to the Registrar, neither of which gave rise to a complaint to the Supervisory Authority.
