INTRODUCTION

The International Registry of Mobile Assets (Aircraft Equipment) ("the Registry") was established pursuant to the provisions of the Cape Town Convention and Aircraft Protocol.¹

The International Civil Aviation Organization ("ICAO") is the Supervisory Authority of the Registry² and Aviareto Limited is the Registrar of the Registry³.

Sections 10.1 of the Regulations for the Registry⁴ ("the Regulations") requires that the Registrar Registry shall maintain updated registration statistics and shall publish them in an annual report. This report shall be electronically accessible to any person".

Section 10.2 of the Regulations states "the registration statistics" shall consist of:

"(a) transactional volumes and revenues subdivided in each case by registration type and geographic distribution; and (b) other compilations of non-confidential information requested by the Supervisory Authority".

This sixteenth annual statistical report is being posted on the Registry website in fulfilment of the requirements of Section 10 of the Regulations.

Activity levels


Following the sudden impact of the COVID-19 pandemic in 2020, there was further economic uncertainty in the industry in 2021. The aviation industry began to re-open albeit at a different pace depending on the region and restrictions. In 2021, activity levels on the International Registry reflected ongoing changes within the industry.

The number of priority search certificates issued decreased by 3.2% to 130,548 from 134,921 in 2020, where 2020 had seen the highest level of search certificates issued since go-live in 2006.

There were 139,281 registrations effected in 2021, an increase of 3.7% against 2020. This figure exceeded the pre-pandemic level of 138,834 achieved in 2019 and was also the highest number of registrations made since go-live. The number of registrations effected through CLOSING ROOM® in 2021 was 103,064. This was a 10% increase on the previous year and represents 74% of all registrations made during the year.

It was a record year for sales on the Registry with a combined figure of 25,382 recorded for sales and prospective sales. This was an increase of 18.33% on 2020 and the highest number of sales registered in any calendar year since go live. The combined figure for international interests and prospective international interests (representing financing and leasing of aircraft) fell by 13.88% in 2021 to 33,977 from 39,456 in 2020 as seen in Figure 1 below.

There was an increase in the number of subordinations registered in 2021 (2,412), up 79% on the previous year (1,345). It appears this was attributable to the financial restructuring of several airlines.




The changes in activity levels against the previous year are noted in the table below.

Administrators and users

The total number of new administrators and users in 2021 rose by 18% to 8,685 in 2021 compared with 7,335 in 2020. Licence renewals saw a marginal rise of 1.6% from 6,181 in 2020 to 6,280 in 2021.



The number of controlled entities created in 2021 rose significantly from 119 in 2020 to 256 in 2021, up 115%. Controlled entity renewals also saw a slight increase of 2.9% from 838 in 2020 to 863 in 2021.

Manufacturer Serial Numbers

By the end of the year, 60 manufacturers were regularly supplying the Registry with updates of the manufacturer serial numbers (MSNs) of airframes, helicopters, and engines. As a result, over 410,000 MSNs are now stored on the Registry system. This information is electronically supplied to registering users. The use of such information, where supplied, is mandatory under Section 5.1 of the Regulations.

The cooperation of manufacturers in supplying this information to the Registry was arranged through the Aviation Working Group.

Registry availability⁸

The availability achieved in 2021 was 99.32% compared to 99.79% in 2020. The drop in availability resulted from an outage experienced with one major key supplier.

Improvements to the Registry system

In April 2021, the payment process on the International Registry was upgraded to comply with global payments industry standards for online payments, in particular Payment Card Industry Data Security Standard and Payment Services Directive (EU) 2015-2366, which requires 2-factor authentication for online payments.

Google Analytics9

Google Analytics™ was first introduced on the Registry in April 2020 and enables better monitoring of user trends on the Registry.

Registry system security

In 2021, Aviareto's Cybersecurity auditor Deloitte Ireland LLP carried out a series of security reviews and penetration tests across Aviareto's corporate IT environment and against the International Registry System, including but not limited to infrastructure and application penetration testing. Risks were identified, evaluated, and categorised. Risks were treated according to the Registrar's risk management framework. Management is satisfied that the issues found have been dealt with appropriately and pose no significant risk to the business.

Liability insurance

Errors and omissions insurance cover reduced to \$150 million in 2021, compared with \$200 million in 2020. Conditions within the insurance market hardened resulting in lower cover and increased cost.

Complaints

Section 8 of the Regulations and Section 14 of the Procedures make provision for complaints to be made to the Registrar under Section 8.1 (operational complaints) and 8.3 (complaints regarding unilateral registrations).

In 2021 there was one complaint made under Section 8.1. Details of the complaint can be found in Table 8 below.

Liaison with the user community

The Registrar conducted its customary annual survey of customer opinion during the second half of the year. Feedback from the user community and the outcome of the survey are important in shaping the programme for the Registry's future development. The overall weighted Registry user experience achieved a composite score of 8.55 (out of 10) in 2021, a marginal decrease from 8.65 in 2020.

The Registrar continued to maintain close contact with the industry, notwithstanding travel restrictions due to the global COVID-19 pandemic. The Managing Director attended a conference of the Cape Town Academic Project in Cambridge, UK in September, and a meeting of the Aviation Working Group (www.awg.aero) in New York, USA in October.

In September, a guide on best practices for electronic collateral registries¹⁰, published by the Cape Town Academic Project, was launched at the seat of UNIDROIT in Rome, Italy. The International Registry contributed its expertise to the development of this guide and the Registrar spoke at its launch.

Tax free status

The concession granted by the Irish Revenue Commissioners to the Registrar exempting corporation tax in respect of its operation of the Registry was renewed for 2021.

International Standards Organisation (ISO)

The Registrar achieved a successful surveillance audit to Standard ISO 9001:2015¹¹. This was with the National Standards Authority of Ireland. Successful recertification audits were also carried out by the British Standards Institute on Standards ISO 27001:2013 ¹² and ISO 22301:2019¹³.

The audit for ISO 22301:2019 was a transition audit, to move from the 2012 to 2019 version of the standard.

Financial performance of the Registrar

The Statement of Financial Position of the Registrar for 2021 as filed with the Irish Companies Registration Office are included in this report.

The Registrar had a surplus of \$120,664 income over expenditure in 2021 (\$1,051,787 in 2020) enabling it to achieve a shareholders' surplus of \$10,378,300 (\$10,257,636 in 2020) comprising \$10,138,265 of retained earnings and \$240,035 of called-up share capital. During the course of the year, capital expenditure on the system of \$1,969,434 was incurred. At year end the Registrar had deferred revenue obligations to its users of \$1,530,395 (\$1,352,249 in 2020).

Cases brought under Article 44 of the Cape Town Convention

Under Article 44 (1) of the Cape Town Convention, "[t]he courts of the place in which the Registrar has its centre of administration shall have exclusive jurisdiction to award damages or make orders against the Registrar".

As the Registrar is located in Ireland, the Irish High Court has exclusive jurisdiction to award damages and make orders against the Registrar. The relevant Irish legislation is the *International Interests in Mobile Equipment (Cape Town Convention) Act 2005* with procedural matters set out in Order 81A of the *Rules of the Superior Courts*, S.I. No. 31 of 2008.

In 2021 two cases came before the High Court in Ireland. The Registrar was a named Respondent in the proceedings as prescribed by the Rules of the Superior Courts.

The cases proceeded under Article 44 of the Convention, and both related to situations where the right to discharge (RTD) holders on several registrations had been dissolved. The Applicants



brought proceedings seeking to have the registrations discharged by the Registrar. The Court ordered the Registrar to effect the discharges and it duly did so.



There is a contractual target to maintain a system availability of 100%, subject to the provisions of the Service Level Agreement. 18 This has been achieved.

Table 7 outlines the availability achieved based on the standard that if any function of the Registry is unavailable to users, then the system as a whole is treated as being unavailable. The average availability for 2021 was 99.32% compared to 99.79% for 2020.

Section 8 of the Regulations, read with Section 14 of the Procedures 19, provide that any person may submit a complaint to the Registrar "concerning the operation of the International Registry" where a matter "relates to the general procedures and policies of the International Registry and does not involve specific adjudication by the Registrar or Supervisory Authority". If, within 30 calendar days of making the complaint, the person does not consider that the complaint has been or is being satisfactorily addressed by the Registrar, that person may submit the complaint to the Supervisory Authority.













Parties to the Cape Town Convention & Protocol by Effective Date






Registrations by Object Type











User Setup versus Renewals






Number of Priority Search Certificates Issued







Registrations Effected *versus* Priority Search Certificates Issued
